Starlighters Return to the Foxfire for 2010 Winter Holiday Formal





The Starlighter members attending the November Winter Formal dance will have the opportunity and responsibility of voting for the 2011 Starlighter Board of Direc-




tors. Current President, Bob Meehan, will present the slate of candidates selected by the Nominating Committee to the general membership at the dance.
